(2) To vote for any candidate for County Council At Large, you must select each candidate you wish to vote for. Your straight party vote will not count as a vote for any candidate for that office.

(3) If you wish to vote for a candidate seeking a nonpartisan office or on a public question, you must select the appropriate place on this ballot.

You are not required to vote a straight party ticket. If you do not wish to vote a straight party ticket, do not make a selection in this section, and proceed to voting the ballot by office.



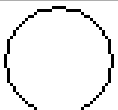
